

COOKIES POLICY

1. Introduction

1.1. You acknowledge that we use “Cookies” and other software, such as web beacons, that automatically collect data information. Cookies are small pieces of data sent from our Site and stored in your browser when you access our Site that will help us improve our Services and your use and experience. The Cookies also help our campaign effectiveness and show which areas and features of our Services have the most count-visits and are best used.

1.2. Cookies do not contain any account or password information, and the Company will not collect information about other websites the Client visits.

1.3. The Client can manage his/her allowed and blocked cookies through the web browser he/she uses. By visiting the Company’s website, the Client acknowledges the terms, conditions, and risks herein. The Client can still use the Company’s services if he/she chooses to block the cookies from the website, but some functions may be defective or not work as designed.

2. Collected Data

2.1. We may collect some information from the device you use when you visit our Site and interact with our Services. You accept that we may gather and review user information or log data by your used browser and, depending on your cookie settings, such as:

- i. Your public IP addresses
- ii. Type of browser or operating system and its version
- iii. Preferred language based on your settings
- iv. Geo-location settings
- v. Time-zone settings
- vi. Plug-ins and other device settings
- vii. Date and time of your Site visit
- viii. Pages you visit on our Site
- ix. Time spent on each page
- x. Error logs you encounter
- xi. Account login details

3. Use of Cookies

3.1. As mentioned above, cookies are small text files that can be stored on your device when you visit our Site. We use different technologies that may obtain your data, such as cookies and web beacons, to understand how you use the Site and recognize returning visitors.

3.2. These cookies are safe and cannot run programs or transfer harmful viruses. Cookies only help us provide content based on your device or browser's specified preferences, so you can have a more tailored experience when using our Site and Services. More specifically, we only use cookies for the following reasons:

- i. Optimize trading experiences, such as remembering your preferred language, location, browser settings, and other preferences
- ii. Retrieve data you previously entered, such as login details and other personalized features
- iii. Maintain Site functions and other contents
- iv. Authenticate identity for security purposes
- v. Assess and manage your use of our Site and Services

3.3. You may accept, decline, block, and remove cookies as your browser or device permits. While most web browsers automatically accept cookies, you can change it on your browser's settings. You can still access our Site if you choose to remove or decline our cookies. However, you may not be able to use some of the Site's features, or they may not work as intended, which may prevent you from getting a complete or proper user experience.

3.4. Cookies and other data collected from the website will remain private and not be distributed or disclosed to third parties.

4. Third-party Services & Limit of the Policy

4.1. Our Site, software, and mobile applications may contain third-party programs, websites, and links, including third-party ad-serving platforms, where these third parties may use cookies and other technologies to collect your data. Consequently, you accept that the privacy terms of such third parties are separate from ours, and we have no control and responsibility over their use of and access to your information. Accordingly, this Policy does not apply to your activities outside our Site.
